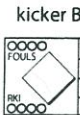

Kicker A fouls twice, then kicks a double



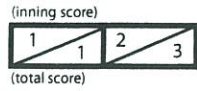
Kicker B kicks a single that moves kicker A to third base

FO = forced out, TO = tagged out, CO = caught out, HO = hit (with ball) out

"Line-up Rule" (Rule C.3) : Kicking orders shall contain between 8 to 12 spots. Kicking orders with less than twelve spots must designate at least three spots exclusively for men and for women, orders with twelve spots must designate at least four spots. Two players may share a single spot in the order as long as both players kick at least once in the game and the lineup contains at least 10 spots.
