Example Scoring:

- Kicker A fouls twice, then kicks a double. Kicker B kicks a single that moves kicker A to third base.
- Kicker A kicks a triple that scores kicker A out, kicker B is tagged out at home.
- Kicker A fouls, Kicker B fouls, Kicker C fouls. After the next two kickers pop out, CO\* is marked for each out and the score is marked as: then in the next inning the team scores 2 more runs.

\*CO = Caught Out, TO = Tagged Out, CD = Caught Dead, PD = Put Down with Ball Out

"Line-up Rule" (Rule C.3): Kicking orders shall contain between 8 to 12 spots. Kicking orders with less than twelve spots must designate at least three spots exclusively for men and for women, orders with twelve spots must designate at least four spots. Two players may share a single spot in the order as long as both players kick at least once in the game and the lineup contains at least 10 spots.
